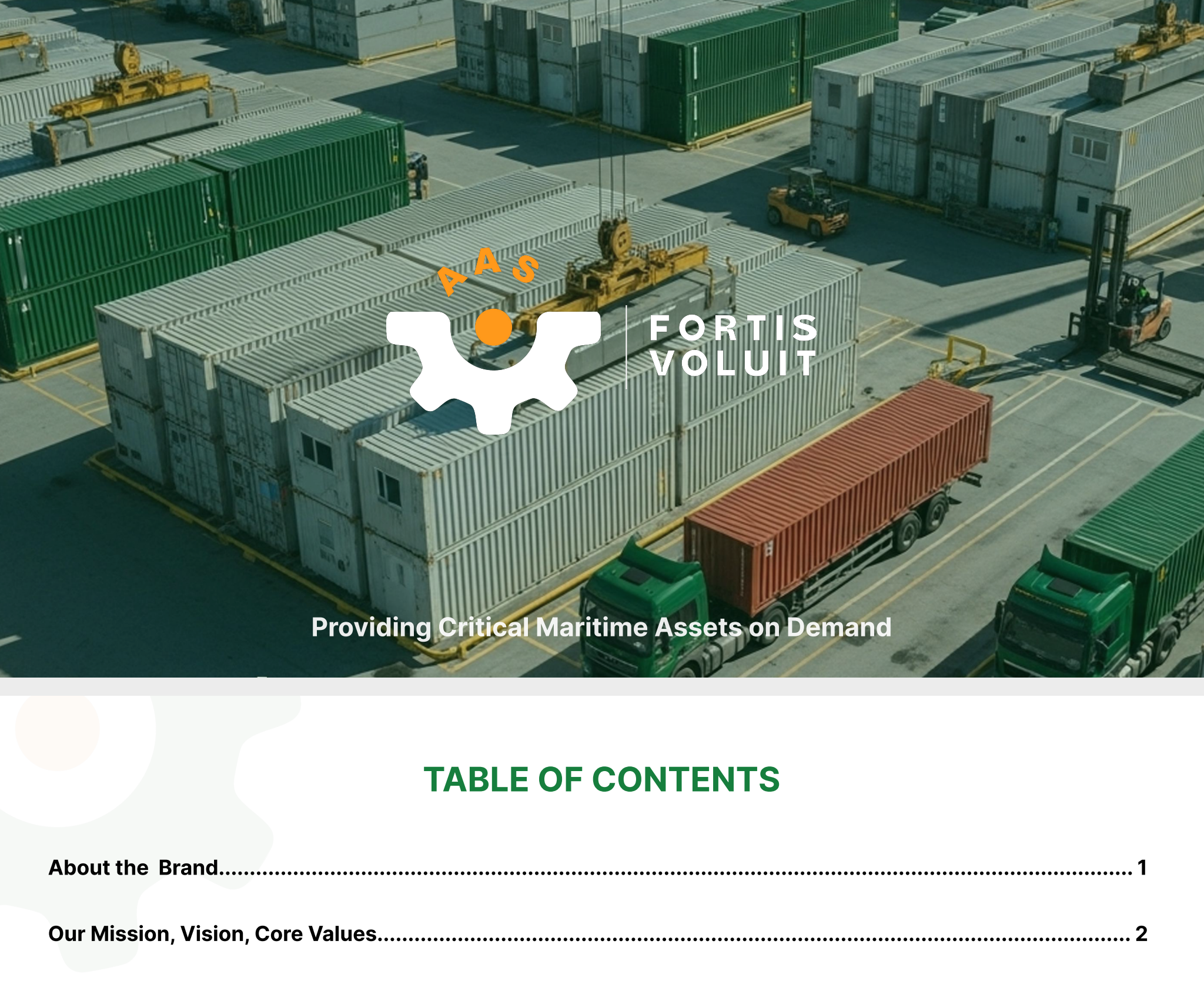
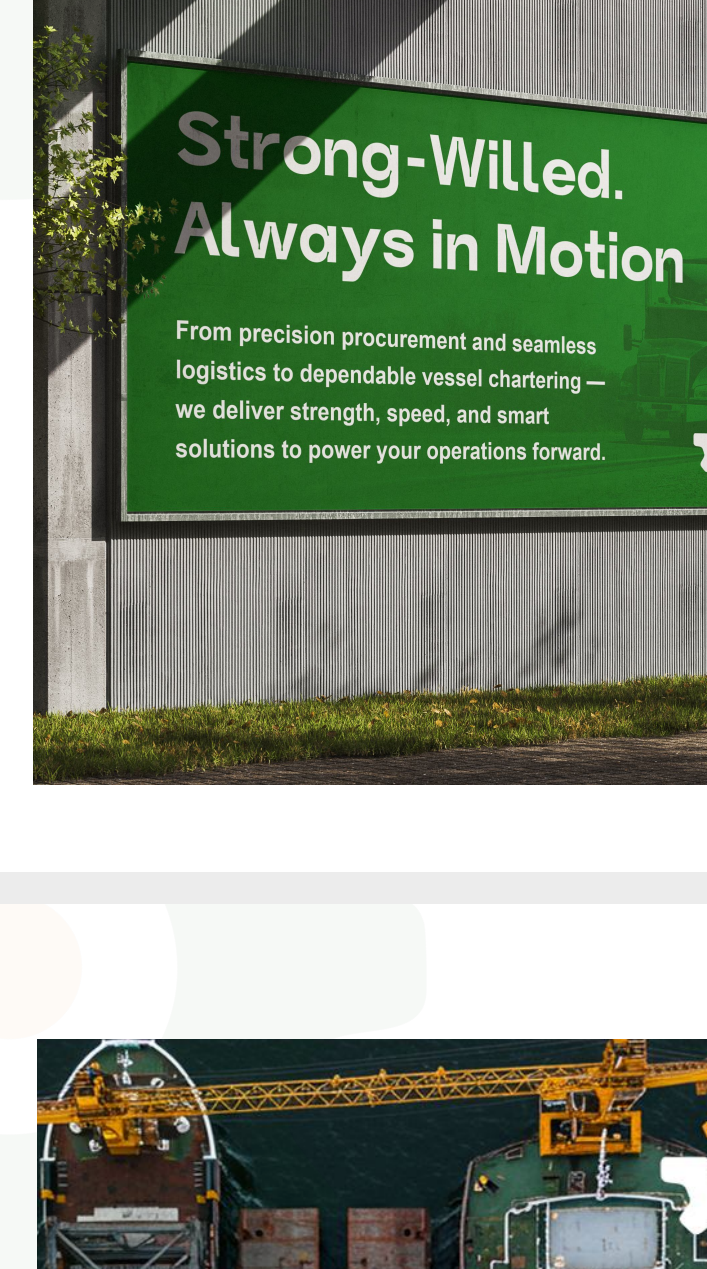

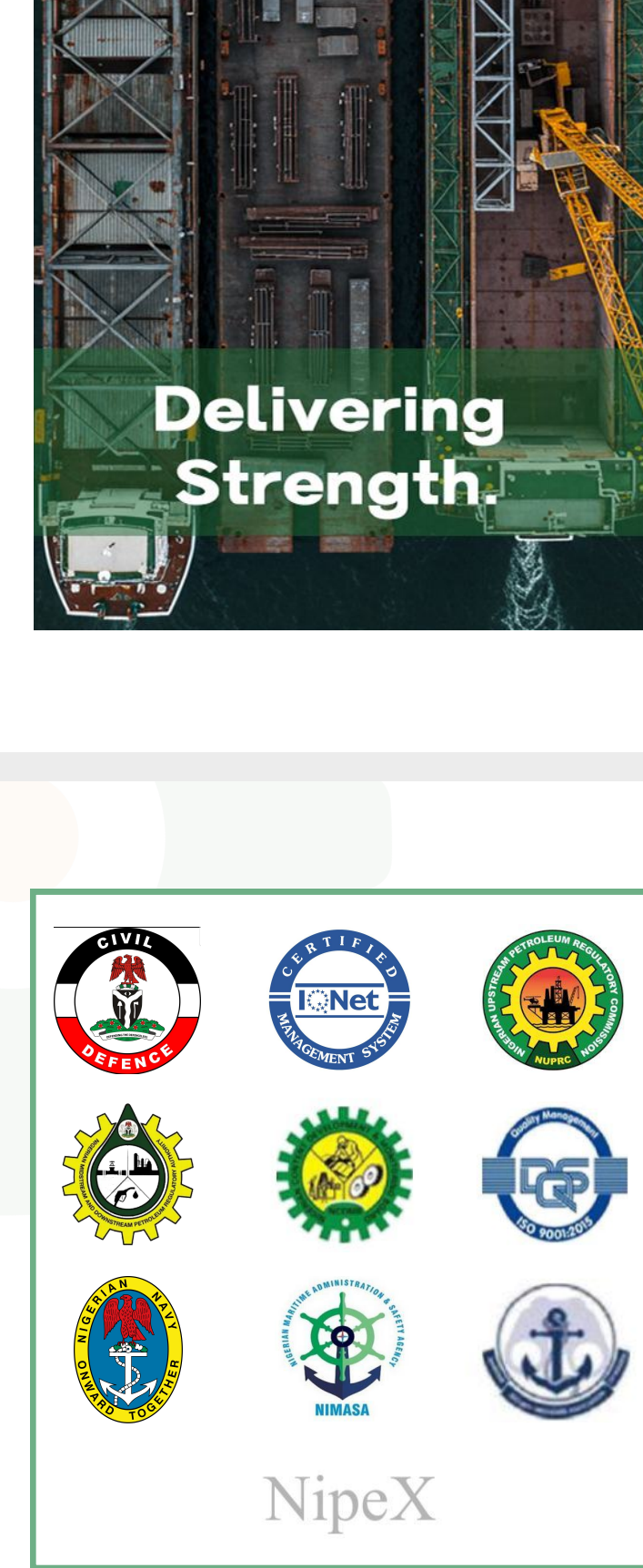
ABOUT THE BRAND

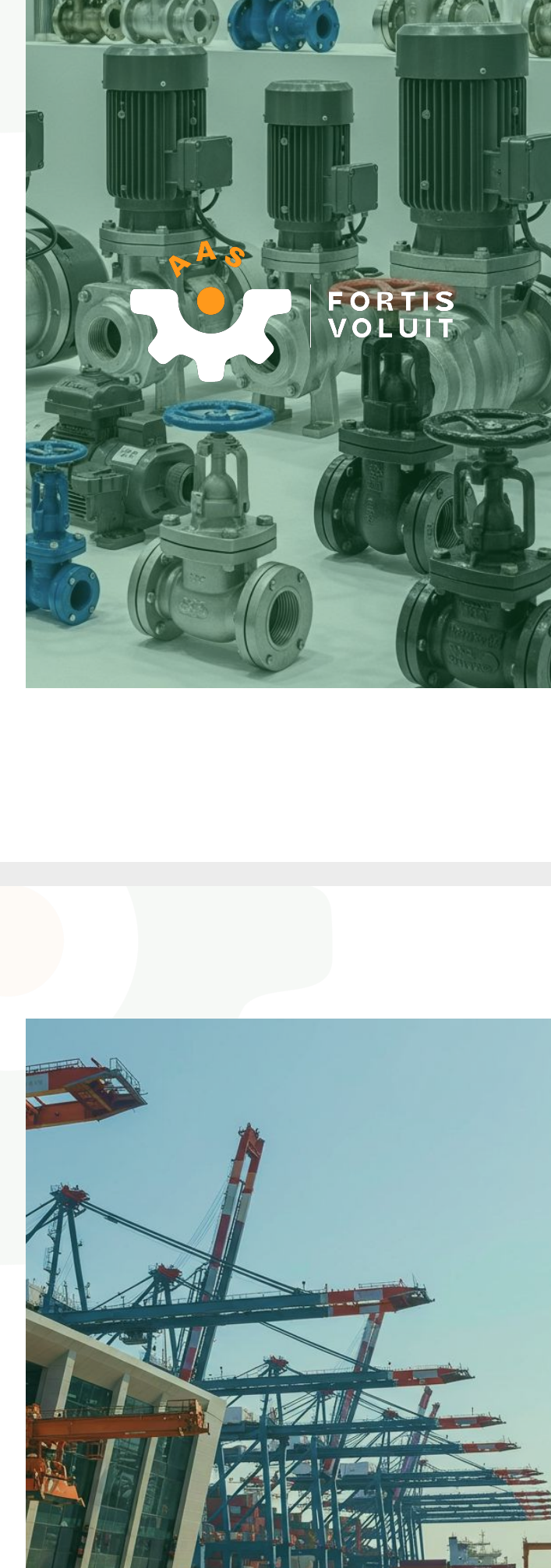
OUR APPROACH

AAS is committed to the preservation of its reputation and integrity through compliance with applicable laws, regulations and ethical standards in our business operations.

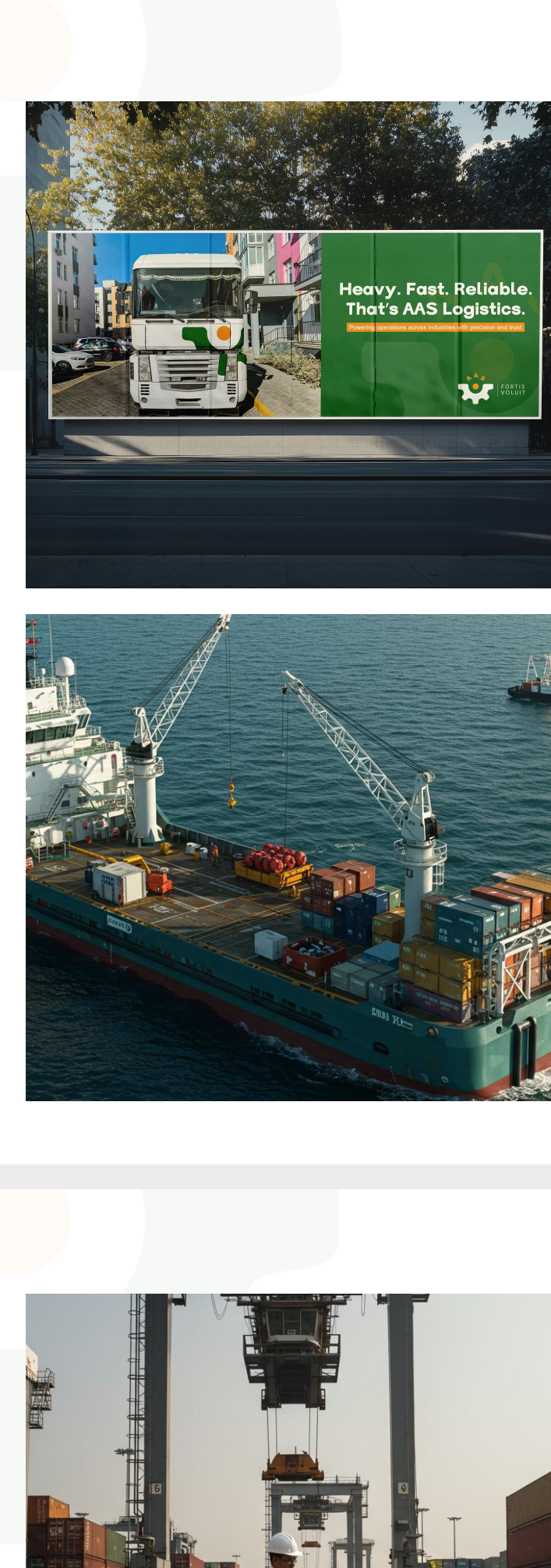
All employees are expected to adhere to these laws, regulations and ethical standards, and management is responsible for ensuring such compliance

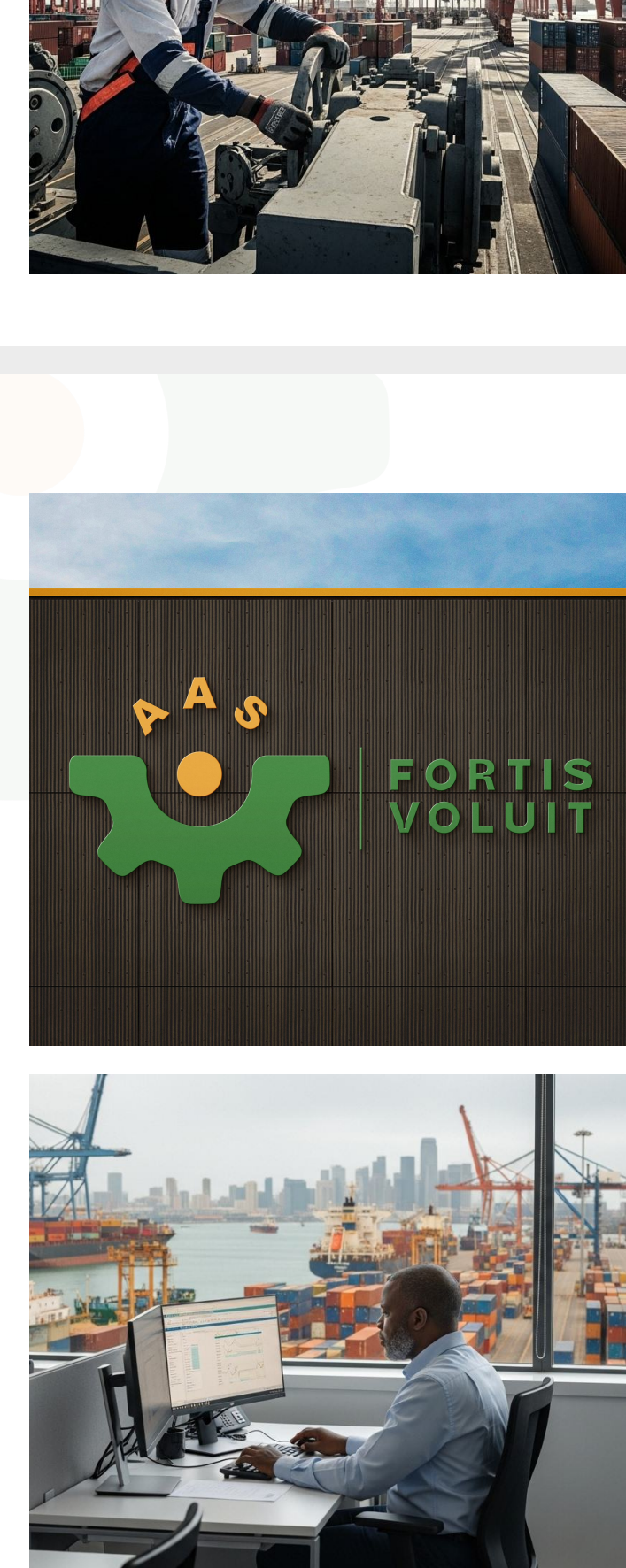

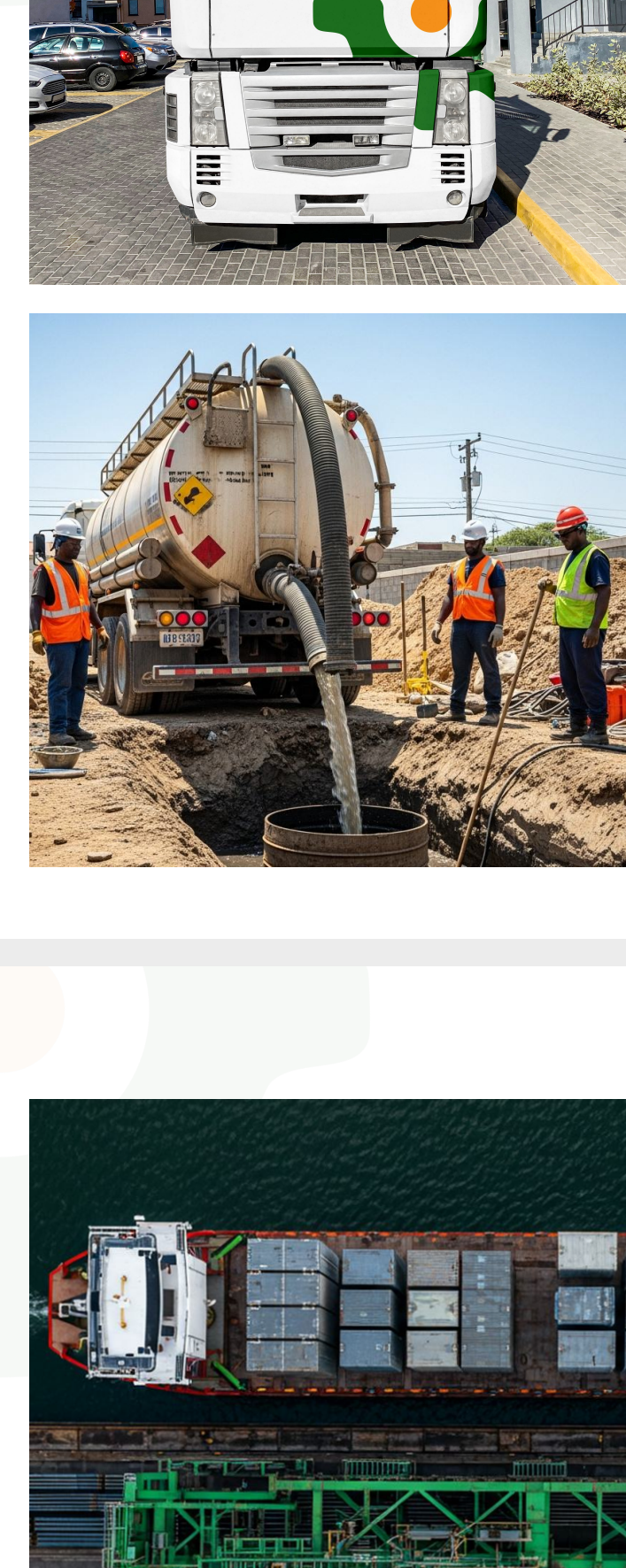

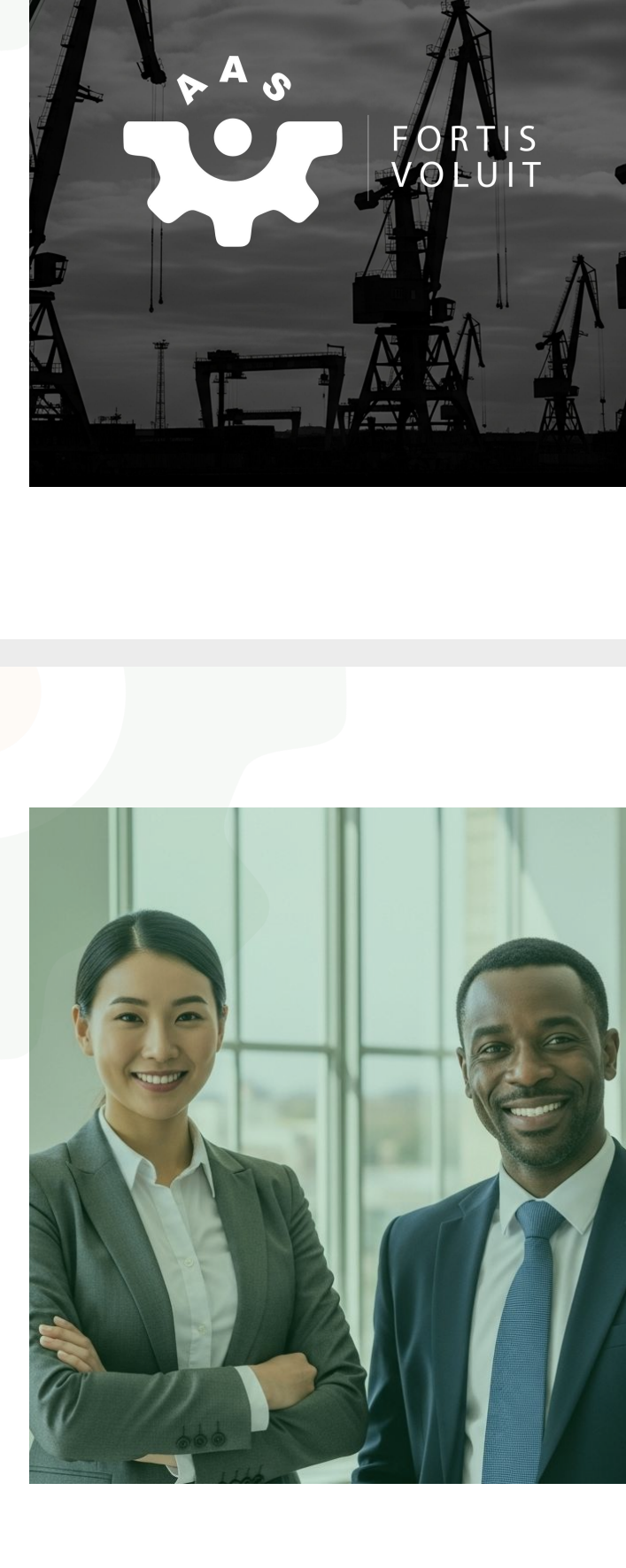
